Biographies



Senator Kate Brophy McGee

Senator Kate Brophy McGee is serving her first term in the Arizona Senate, representing Legislative District 28. The district includes North Central Phoenix, Biltmore, Arcadia and the Town of Paradise Valley. Previously, she served three terms in the Arizona House of Representatives (2011-2016).

Senator Brophy McGee is Vice Chair of the Senate Health and Human Services Committee, Vice Chair of the Senate Education Committee, and serves on the Transportation & Technology Committee. During her tenure in the House, Brophy McGee served as the co-chair of the Joint Legislative Child Protective Services Oversight Committee. She is a member of the Child Help Arizona Board, ASU's Morrison Institute of Public Policy Advisory Board, the Flinn Foundation's Bio Sciences Roadmap Steering Committee, and is a proud member of Phoenix Rotary 100 and Sunrise Toastmasters.

During her legislative tenure, Brophy McGee has served on numerous key gubernatorial and legislative committees. Most recently, she served on Governor Ducey's Substance Abuse Task Force and Sexual Assault Evidence Collection Kit Task Force. She sponsored the legislation establishing the Department of Child Safety as a stand-alone agency during an historic May 2014 Special Session of the legislature. She was key in the 2013 Medicaid restoration, led by Governor Jan Brewer, and led the charge to restore KidsCare funding in 2016.

Prior to her election to the legislature, Senator Brophy McGee served nearly a decade on the Washington Elementary School Board, including four terms as Board President. She also served six years on the Arizona School Facilities Board, including one term as Chairman. She continues her many community-based volunteer activities in addition to her current legislative duties.

Mary Rimsza, MD, FAACP

Dr. Mary Ellen Rimsza is board certified in both Pediatrics and sub-board certified in Adolescent Medicine. She received her AB degree from Washington University in St. Louis and her MD degree from Drexel University School of Medicine. She has been a member of the University of Arizona College of Medicine and Arizona State University faculty and served as Director of Health Services at ASU. Since 1997, she has served as chair of the Arizona Child Fatality Review Program. Her research interests include evidence-based child advocacy, prevention of accidental and non-accidental deaths, and health policy.

Dean Coonrod, MD, MPH: Maricopa Integrated Health System

Dr. Coonrod is Chair of the Department of Obstetrics and Gynecology at Maricopa Integrated Health System and District Medical Group and is a Professor at the University of Arizona's College of Medicine. He actively practices as a clinician, researcher, educator, and advocate to victims of domestic violence. He is a member of the CDC Clinical Workgroup on Preconception Care, Arizona Perinatal Trust Board, and Arizona's Maternal Mortality Review Team. He has published multiple research articles on perinatal and preconception care. He directs an internatal clinic providing care for women between pregnancies who have experienced an adverse pregnancy outcome.



Kristin Stookey, CRNP: Arizona Family Health Partnership

Kristin Stookey, CRNP is a Certified Registered Nurse Practitioner with over 27 years of experience providing reproductive health services to women, men, and teens. She leads the Arizona Adverse Childhood Experiences Consortium to increase awareness of the impact of childhood trauma and promote resilience. 


